SUBJECT : BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF CONTRACT FOR PROCUREMENT FOR THE RENTAL TECHNICAL SUPPORT SERVICES AND BROADCAST EQUIPMENT INCLUSIVE OF SUPPLIES AND MATERIALS DELIVERY, INSTALLATION, INTEGRATION, TESTING, COMMISSIONING, ON-AIR TECHNICAL SERVICES AND PRODUCTION MANAGEMENT SERVICES FOR THE INTERNATIONAL MEDIA CENTER (IMC) FOR ASEAN 2017 CHAIRMANSHIP (BIDDING NUMBER 17-ASEAN-003)

WHEREAS, the Presidential Communications Operations Office (PCOO) through the 2017 General Appropriations Act, pursuant to Administrative Order No. 48 creating the National Organizing Council (NOC) for ASEAN 2017 under which PCOO is the chairperson for one of its Committees, namely, the Committee on Media Affairs and Strategic Communications (CMASC) and by virtue of the 22 March 2016 Memorandum of Agreement between the two (2) agencies, intends to procure goods for the Rental Technical Support Services and Broadcast Equipment Inclusive of Supplies and Materials Delivery, Installation, Integration, Testing, Commissioning, On-Air Technical Services and Production Management Services for the International Media Center (IMC) For ASEAN 2017 Chairmanship;

WHEREAS, on 15 February 2017, the PCOO posted an invitation to bid for the abovementioned procurement.

WHEREAS, on 08 March 2017 at three o' clock-in the afternoon, only one (1) bid proposal was submitted to the PCOO BAC Secretariat from Solid Video Corporation (hereby SVC for brevity) which was opened at 3:01 P.M. of the same date;

WHEREAS, after conducting evaluation, post-qualification of the bid proposal of SVC, and submission of its latest income and business tax returns filed and paid through BIR Electronic Filing and Payment System (eFPS), the BAC and TWG jointly found SVC's submission compliant with the requirements of this Office;

NOW, THEREFORE having considered the foregoing circumstances, the PCOO BAC unanimously resolves to declare SVC's bid as the Single Calculated Responsive Bid (SCRB) and to recommend to the Head of Procurement Entity the award of contract to SVC with a bid price of **THREE HUNDRED EIGHT MILLION TWENTY TWO THOUSAND FIVE HUNDRED TWELVE PESOS (PHP 308,022,512.00)**. The corresponding Notice of Award will be issued upon approval of the Secretary while the Notice to Proceed will be issued within three (3) calendar days from the date of approval.
