

## **SPEECH OF PRESIDENT RODRIGO ROA DUTERTE DURING THE 65TH GENERAL ASSEMBLY OF THE LEAGUE OF CITIES OF THE PHILIPPINES**

[Delivered at Shangri-La the Fort, Taguig City | 21 November 2017]

Kindly sit down. Thank you for your courtesy.

Interior and Local Government Officer-in-Charge Catalino Cuy. By the way, the regular appointee... He cannot assume the office of the Office of the Secretary because there is a prohibition and it's really funny.

Sa DILG lang 'yan. Peculiar. In other government offices, even if you just retired yesterday, you can fully assume the powers of the office the day after but I still have to find out the reason why ang sa DILG...

So but let me introduce to you si General Año, the incoming [applause] he's the real hero of Marawi, for the many times that I was there. Sir, salamat sa --- the singular honor of; the League of Cities of the Philippines national president Edgardo Pamintuan; LCP national chairperson Maria Laarni Cayetano; the local city mayors and local officials present; mga kasama ko sa goberyno; mga kababayan.

Let me see now. First problem is really development of your places.

Hanggang diyan lang muna tayo ngayon but you can be very sure that whatever was divided, it was divided equally.

I saw to it there was no favoritism in the preparation of the budget. However, the amount, whether big or small, ang order ko talaga is lahat mapagbigyan and no favoritism or larger than the others. [applause] And you can see it sa GAA, makikita naman ninyo eh.

And second is really the law and order of our country; and third, which is really closest to your heart, 'yung police supervision.

But let me start dito sa progress ng ating ekonomiya.

It is a very slow start for all of us. Maybe we have increased the GDP by so many points but it does not really tell the story of how the economy is going on.

Not really after everything has settled down. It's a volatile thing and, you know, it is also dependent on what happens in the national scene and the global perspective. You have to, you know, take those into account.

Now, dito sa development, if you can manage on your own, I'd be happy. If you can go out and strike some deals there and somebody, big or small, would try to develop your places, at kung kaya ninyo...

I don't know about Dominguez itong sovereign equity but --- 'yung guarantee. But kung kaya lang at saka hindi masyadong malaki, okay ako because you know, some others would really insist on a sovereign guarantee.

Titignan ko lang but I cannot promise you. But if you can strike a deal somewhere and it is good for your city, let me know and I'd be willing really to talk about it with you.

Anyway, the incoming DILG Secretary will be there and I think he'll be assuming in the next few days. He will just man The Fort in the meantime that he qualifies.

You can always talk to General Año. He is well rounded, he has a structural mind to understand your problem and, you know, you can always depend on the national government.

Ako lang naman, hindi ako nagpapa-corny. I'm not trying to --- mag-jamming-jamming. Magdiretsahan na lang tayo. Huwag lang 'yung corruption.

I am really, really against corruption. Hindi ako pwede diyang makipagdeal-deal ng mga sa baba because I think that it's about time that we really give the Filipino a respite of corruption in the Philippines.

All the years, every administration has had, always, as a component in their development over these years, meron talagang corruption 'yan. And it is not really --- impossible to just say, "You erase it overnight."

But if you can just minimize it lalo na dito sa baba ninyo, mabuti 'yan. But pati dito sa national.

Pero dito medyo kaya ko talagang ipitin, sakalin and we have the Congressional Act of itong cutting red tapes.

Kasi ako, nung mayor ako, ewan ko kay Inday kung ganun pa rin, we process papers three days.

'Yung iba, if it requires an ocular inspection somewhere, here and there, it's about 10 days.

Itong mga director, 15 days lang. And you know what? Even the Cabinet members are only given 30 days to act on the papers.

They must release the papers, whether approved or not. In 30 days talagang bitawan nila 'yan. That is the rule up.

So I suppose that down below, 'yung mga permit-permit, business permit, takes --- during my time, most is three days.

After three days, you have to --- do not release the papers to the applicant, you release the papers to me with the corresponding explanation why it took you three days to do it.

Para masundan mo talaga ang takbo. But this is just a suggestion. You can do your thing, whatever you want.

Bahala na kayo basta the Red Tape Law, I think only gives you about 30 days for business permits. And that should be okay kasi ang karamihan, ang reklamo nila sa baba, hindi masyado sa taas ngayon.

Pero may I just ask you, please, I plead that sabay-sabay na tayo dito na itong sa corruption, medyo i-minimize natin.

Or alam mo kung sino eh, 'yung mga... Lalo na 'yang mga contractor na puro laway lang talaga, iwasan na lang ninyo, walang mangyari eh.

Sa totoo lang, 'yung mga kaibigan magdala-dala ng papel, alam man ninyo pag ano pa lang.

You would know the personalities of your city or of your town kung sino 'yang negosyo na yumaman, lumaki pero laway lahat.

Sa totoo lang, gusto ko lang sabihin, eh p\*\*\*, kung ibigay mo lang naman sa iba, eh 'di iyo na. Bakit mo ibigay sa mga...? Mas maraming tao, mas maraming satsat.

But if you can minimize it, try to minimize it. You know the persons who go around tapos mag... The classic really is 'pag naipabili nila 'yan, kikita sila or they are into cabal or cahoots, itong mga --- itong mga 'to, maghahanap ng bidding and yet they compete, they are there kunwari. Tapos ibagsak nila, maghingi pa sila doon sa nanalo. Kaya 'yung mga projects, talagang of no quality at all.

'Yang tinatawag sa probinsya o sa siyudad, 'yung parang ni-lipstick mo lang 'yung daan. After a few days, wala na 'yung aspalto, wala na, because of corruption.

So some survive the mayorship doing it. I do not know of a particular person. But some also do not even how honest they are, it's the --- it's how the dynamics of politics sa baba.

Pero itong sa droga, alam mo na naging parang obsession ko na tuloy. Pareho man tayo mayor noon, nakikita ko kasi. Nakikita ko sa dalawang mata ko.

Davao used to be a very --- bigger than usual 'yung mga doses doon. But when I became mayor, 'yun ang unang tinarget ko talaga.

You know why? I was a prosecutor. And you can just imagine the pain in my heart every time a case is dismissed. One, because hindi sumipot ang pulis or the police nabayaran --- or ito bantayan ninyo 'yang process server.

He's the number one --- kung gusto mo talaga linisin 'yung siyudad mo, bantayan mo 'yang process server.

Because their return are taken at face value and nobody would want to review na kung ano, saan niya nilakad 'yung summons.

Usually doon, ilagay lang nila na "cannot be located" or "has transferred residence." Wala 'yan, inimbento lang nila 'yan.

Ang fiscal naman is really pagsabi dito ng judge, "O fiscal, ready?" "I am not ready Your Honor." "Why?" "In the summons here shows that the witnesses are --- were not identified or the accused himself cannot be located anymore." So nandiyan lang 'yan.

Alam mo may... Bigyan ko kayo ng isang example talaga ng racket ng pulis ha.

Kasi si General Año, malaking --- kaya ko siya kinuha talaga eh. Dahil dito, medyo sasagad-sagad sila.

'Yung pulis sa inyo, 'yang mga maldito bantayan ninyo 'yan. Kung hindi ninyo matiis, ipapatay mo na lang. Ang p\*\*\*\*\* i\*\* 'yan.

Alam mo 'yang style na 'yan, dito sa Maynila. Maghold-up 'yan. Marami naman dito 'yan, maghold-up na pulis.

So 'pag pumutok 'yan, magtago lang 'yan. Hindi naman hinuhuli 'yan eh, kabaro. Magtago lang 'yan, they disappear.

So a case is filed. Tapos they disappear for a while mga two --- one, two years. 'Pag lumamig na ang panahon or tingnan nila hindi na interesado 'yung nag-demanda o talagang umalis na, cannot be located, fa-follow up lang 'yan.

Then suddenly, they will appear in court with a counsel and say, "Your Honor, we are here to face the trial of this case against my client because we are as a matter of fact, we believe that we are innocent of the charge."

Magda-drama na 'yan. Then pagsabi, "O fiscal, are you ready for today's trial?" Tingnan 'yan. O minsan naman 'yung process server bayaran.

'Yung ulol na --- 'yung matatanda na 'yan sila, 'yung mga outcasts na sa pulis, 'yung nandiyan sa summons pati warrant. 'Yun, tingnan mo 'yan. Either nabayaran 'yan at ilagay nila cannot be located or has transferred residence.

At face value, basahin ng clerk 'yan. "Can we refer to the records?" "Cannot be located". O 'di mag-insist, "We must have a trial, Your Honor."

Ganun 'yang pulis eh. Tapos sabihin na --- ang fiscal naman nagkakandarapa, "Your Honor, may we ask for a transfer?"

"I give you... I warn you, the next time that you are not ready, this case will be dismissed." Tapos next trial. Ganun rin.

'Pag nawala na, wala ng interest kasi nagtatago eh. Minsan naka-archive 'yung record.

Kasi 'yun namang mga Pilipino. This is how injustice is going on. Sabihan ko lang kayo. Tapos 'pag next trial, sigurado wala.

"Your Honor..." ang boses niyan... "We demand a trial because the continued delay of this case is a violation of my client's constitutional right to speedy trial."

Pagalit-galit na 'yan ngayon. Lalo na kung ang judge p\*\*\*\*\* i\*\* ulol kasali. Ayon, second hearing 'yan. 'Pag wala 'yan, dismiss.

Ganun ang nangyari. So thousands of them. If at all, merong conviction diyan which is really or are few in between, in between those years, far and wide.

Pati 'yung judge dito. May isang judge dito na almost 900. May isa pang, isang prosecutor, wala lang man conviction ni isa.

So nagsulat ako diyan sa ano, sa Supreme Court. Anong klase itong mga huwes na ito? Corrupt talaga 'to. Walang...

And that contributes to the impunity. Sabihin nila, impunity of killing.

Ako? P\*\*\*\*\* i\*\*. What about impunity of the criminals? Eh mabuti't na lang ako at least kung pina --- naaresto't namatay, kriminal.

Itong dito, they are perpetuating the impunity of criminals. Lugi talaga ang Pilipino diyan. Kaya ako nangbabastos.

You know, I am not really that kind of person pero because of the exasperation and the attitude ng... Alam mo ang human rights, magsabi 'yan sila, ito 'yung human rights na namatay, 10,000, 15,000, 20,000. Lagyan mo ng 100,000. Walang ginawa kung kunin 'yung listahan kung sino 'yung namatay.

Tapos, extrajudicial killing. Pagdating dito ng mga ugok, lalo na itong mga puti, talagang walang silbi sa buhay 'yang mga y\*\*\* na 'yan.

Sabihin na, "You know, Duterte, it is a social problem. It is a social impact. It is a health issue."

O kung social issue, health issue, then titingnan mo ang likod. If you are really a journalist of... worth your --- Tingnan mo bakit naging social issue? How did it start? What started it? When was it taking place? Bakit nagka-ganun?

'Di makita nila puro droga. How many people were contaminated? How many people are into it? How many people are sick?

'Yan ang tama. Kaya kung magpunta ka lang dito tapos kunin mo extrajudicial figure number, hindi ko pa siguro kung tama ba 'yan o hindi.

Kasi nga 'yung matagal na ako nagbitaw. I ordered the PDEA to operate only to the exclusion of the all law enforcers, pati NBI. Sabi ko, "Umalis kayo diyan."

O tapos sige pa rin ang patayan, sige pa rin ang --- but look at the consequences. If you ask me, is it succeeding? Is PDEA --- is PDEA qualified? Yes, of course.

But is it capable of enforcing the law with 2,000 agents? I'll tell you, of course not.

Whether it has really improved the situation or not, we will know. I have not asked anybody. But you're... Nandiyan kayo. You are sure of tumaas ba 'yung mga rape diyan.

Wala naman ibang gawain 'yan 'di magnakaw because... You know my --- to my chagrin, itong ulol na...

Be careful about America. Not really government, ang State Department. There are completing multi-racials diyan eh. May mga empleyado na Latino, may empleyado na Chinese, may empleyado na --- mga...

It's a migrant's hellhole, ika nga. Tapos kanya-kanya 'yan silang ano... To just, to just illustrate to you. I do not think if you remember that black doctor brought by Callamard.

And he had the gall to go in public before TV and said that, "No, ang droga does not harm. It is not something which is permanent."

Biro mo... Gusto kong sampalin eh. Sa totoo, kung makita ko 'yung... Masampal ko siguro sa totoo lang. [Saan na 'yung aide ko? Meron ba kayong...]

They are fighting with each other and making us stupid before the... There is a release now. International Narcotics Control Board precursors. Look at the logo. World Health Organization.

Ayan lahat cannabis, nandiyan lahat 'yung effect. "Cannabis smoke contains 50 percent more tar than high tar cigarette which puts users at the risk of lung cancer and other respiratory..."

Hindi masyado. Tama sila because itong cannabis, poppies, heroin, cocaine are derivatives of opium plant and it's organic.

Kaya dito sa... In the following pages, cocaine. [Bigyan mo sila Bong, lahat ng mga mayors.]

"Mixing cocaine with alcohol is a dangerous cocktail and can greatly increase the chances of sudden death."

Kaya 'yung mga artista sa Amerika, 'yan man 'yan. O dito, ecstasy. "Tablets or pills that are sold as ecstasy may contain other potentially dangerous substances which can vary widely in strength and effect."

Tingnan mo, okay lang 'yan. Heroin. "Risks: uses risks overdosing on heroin, which can lead to coma and death through respiratory depression."

Tingnan mo ha. LSD. "The physical effects are small compared to the psychological and emotional effects. They include dilated pupils, increase in heart rate blood pressure, loss of appetite, sleeplessness, dry mouth and tremors."

Ito 'yung mga sa Amerikano.

Methamphetamine. Shabu. "Effects: methamphetamine use sometimes triggers aggressive, violent and bizarre behavior among users."

Because among itong mga ano, it is only shabu who is a deadly mixed chemicals. It is not organic.

Pati ang baterya ng --- baterya na ginagamit --- 'yung tubig, tubig ng baterya if you want to know.

Kaya dito sila, lumalaban talaga ng pulis. Pati dito mo makita... Alam mo, almost five days ago, seven days ago, pinutulan niya 'yung asawa niya ng ulo tapos sumigaw siya, lumabas siya, "Wala na tayong problema kay Duterte. Pinutulan ko na ng ulo."

Eh 'di bizarre. Asawa niya ang pinutulan niya ng ulo. Kaya itong mga 'to, ito --- alam naman ninyo. Sa siyudad ninyo nangyari na 'yan. They rape, they kill.

Sa Bulacan, ni-rape 'yung mother-in-law na buta --- na bulag, tapos 'yung daughter, pinakialaman 'yung 14 anyos na anak, pati 'yung isang one-year-old.

Sino ba namang...? May problema talaga tayo sa drugs. And early on, it did not really occur to everybody that it was in that dimension, kasi kung hindi ako nag-Presidente, hindi man lumabas 'yung by the hundreds of thousands.

To date, they were about six --- one six million. Hindi biro 'yan eh. Kaya talagang ako, sa Bisaya, paningkamot, I really tried my best to declare a war.

At ganun talaga ang utos ko hanggang ngayon. With or without itong human rights na ito, with or without, sinasabi ko na maski sinong leader, do not f\*\*\* with me about drugs. It's killing my country.

Biro mo millions? And ang ayaw ko diyan, they have reduced a number of Filipinos to slavery. To what? Drugs.

They have to look for it everyday to get a fix, and when the monkey rides on their back, makati na ang katawan, 'pag walang pera 'yan, maghanap talaga ng alebyo 'yan.

Sometimes they rape, sometimes they steal, it results minsan in the killing. 'Pag high na, they go about raping women and --- tapos papagbintangan 'yung pulis.

Kita mo naman sa TV, one afternoon, a guy was going around, threatening everybody with a knife, hinarap ng pulis maski may baril, ang pulis atras nang atras lang, hanggang naipit at natumba, binaril niya.

Kaya ako hindi ako nagsasabi lahat kayo, pero ito talaga ang masasabi ko sa inyo, magprangkahan tayo. Mahal ko kayong lahat, magsisilbi ako sa inyo, magpakaulila ako kung kailangan.

Pero 'pag pumasok kayo diyan sa droga, kagaya kay Parojinog pati kay Espinosa, talagang yayariin ko kayo. Believe me. Maaabutan ko kayo. I don't give a s\*\*\* about 'yang human rights. We're even [inaudible].

What makes it really very odious is that nandiyan ka sa power and you use the office as the platform of your drug activities. That is what happened to Parojinog.

And to think that he was my friend, nagpapadala ng alimango 'yan, almost weekly sa akin, isang sako. Maybe he was thinking that, you know, baka matimpla niya...

Pero when he started to kill his own policemen, 'yung galing --- lumaban sa kanya, ayaw na niya.

'Yung pinatay na niya 'yung apat na pulis, 'yung dalawa hindi pa makita 'yung katawan, 'yung dalawa nakita na 'yung pagka --- nakauniporme pa eh.

Sabi ko, "P\*\*\*\*\* j\*\*, tatapusin ko talaga 'tong animal na 'to." Trabaho ko 'yan eh. It's my job to protect the Republic of the Philippines and the people.

'Wag kayong magkamali diyan kasi madidisgrasya kayo. Alam ko it's lesser income, wala akong sinabing kayo. Pero may namatay na kasi. 'Yang kay Parojinog talagang niyari ito.

Walang --- kita mo sa Ozamiz, walang industries, walang cottage industries, walang factories, pero buhay ng mga tao doon almost maganda ang standard of living nila.

Well, everybody was selling drugs around Mindanao at ayaw maniwala nitong mga --- sabi ko, "Drugs was fueling terrorism in Marawi." Sinabi ko na 'yan noon.

Marami akong pinsan, Maranao --- ang lola ko, Maranao. Marami akong pinsan sa Marawi na nagsasabing masama na ang lagay dito, hindi ko lang alam kung gaano kasama.

But even my own relatives were calling me, nandiyan sila ngayon, kasali sila sa evacuees. Sila ang nagsabi na talagang masama na. And so, maski saan ka magpunta talagang...

Ganito 'yan eh, I will not take much of your time, when I was mayor, hindi man ako nagyayabang ng siyudad, go to Davao. 'Yan lang ang ano ko, dahil 'yun lang rin, in my own small way na ang talagang na-crank ko, Davao.

Droga? Meron, sachet-sachet. Pero meron ba dung mga, sabi mo, mga rape-rape na ganun? Pagka ganun, talaga...

Tama 'yan, impunity --- p\*\*\*, i-control mo muna 'yung impunity ng drugs, 'wag kami. You control the impunity of the drug people who are producing shabu.

When I was mayor, I said, "Do not destroy my city. I am not a policeman, I am not a peace officer, I am not an NBI. I am here before you to present myself because I will build a city."

"But kung meron na," sabi ko, "if I am there already, do not destroy the city because I will kill you. And do not destroy the young people of the city, because I will destroy you."

So what's wrong with that statement? Kaya hindi sila makademanda sa akin, for what? When you say that, "I'll kill you for destroying my country", that is a very legitimate statement.



How can you debate with that kind of... Ngayon, sabi ko, "I am..."

Nandito na ako sa opisina na ito, then nakita mo naman nag-surrender, by sheer number, hundreds of thousands.

So sabi ko, ang utos ko sa pulis, "Destroy the organization." How else can you be less eloquent in giving that order? "Destroy the drug organization. Destroy all."

Talagang if you destroy a laboratory, if you raid something there it really becomes a war. It is really a war kasi the sheer numbers.

Ngayon, ganito, "Bakit ito si Duterte, ang binibira ang mahirap?" P\*\*\*\*\* i\*\* mo, ka-bobo mo naman. Diyos ko po.

Shabu is marketed amongst the poor. Itong mga mayaman na mga b\*\*\*\*\* na nandiyan sa Forbes Park, Dasmariñas, mga elite of socie --- the so-called Four Hundred of Society --- cocaine 'yan, heroine.

And it does not destroy the minds overnight, unlike shabu, the immediate --- the urgent thing there to worry is that it shrinks the brain progressively hanggang talagang mag-kuyos na and sabi nila may rehab sa shabu.

Well, I'm sorry to say to you now. There can be no rehabilitation. But whether or not they continue to be criminals, that is a question mark.

But whether he can live a normal life thereafter, I am... I am one of those who'd tell you, "Patay na 'yang bata na 'yan. Patay na 'yang bata na 'yan."

He's insane. He cannot be an outcast because may pamilya 'yan. Wala na 'yan. Because once the brain shrank, it stays shrank.

Wala namang... Wala namang ano diyan na i-bloat mo uli. Kaya ma --- I really thank you for this time para ma-prangkahan ko kayo na... Hindi ako hihinto. 'Pag ako maghinto, that would be a grave sin.

Hindi ako pwedeng maghinto dito sa kampanya knowing very well that it is destroying my country. I will never stop the drug war.

Now let us say, it's PDEA. Is it getting better or getting worse? If it's getting worse, then I'll have to call the police again.

I don't give a damn about 'yang mga opinion-opinion. To h\*\*\* with you. I have a job to do and I will do it para ipakita ko lang sa kanila.

'Yung ni-rape na babae, sinunog. And it's replicated all over the country. At any given time, I lose about two policemen, three soldiers in a raid.

Sa Mindanao kasi 'pag mag-raid, lalo na sa Marawi, prangka-prangka tayo, hindi pwedeng mag-raid ang police. They do not have the firepower and everything.

'Pag mag-raid 'yan, just like what happened in Lanao, kita mo ang unang namatay mga Marines. Kasi tinawag ang Marines, kasi pagpasok nila doon, binakbakan na sila ng --- pinaulanan sila ng bala. So the only unit there na may ano is the military. So the Marines went in doon sa Mapandi.

I just came from there to celebrate their heroism. Doon ang namamatay, maraming namatay. Ang maraming namatay sa akin doon, 'yung sundalo ko.

Police, lesser, kasi hindi man mag-breach ang police. They do not do the breaching. It's the military. Otherwise, walang mangyari.

So there's still time actually to --- pero kung --- isipin ninyo. "Mayor, suspetyoso ka ba sa akin?"

Well, in the sense, ganito 'yan eh. Minsan kasi 'yang tawag-tawag. Meron ako talagang nagsususpetsa ako na nandiyan, naglalaro o nagsu-supply o gumagawa.

Karamihan diyan, 'yang sabi na na-deprive ng police authority, they are all penchant to protect our leaders.

Kasi 'pag nahuli 'yung anak ng barangay captain tapos magsumbong, "Mayor, 'yung anak ko..."

Minsan sabihin, "Tawagan natin police." "Ano bang nangyari diyan?" "Sir, nahuli na." "Isang sachet lang pala. Bitawan mo na."

'Yan, automatic 'yan, 'pag ginawa mo 'yan, ang impression niyan doon sa police is really nandiyan ka or you are a protector kaya umabot ka doon sa listahan, even how innocent the call was or is.

Nakakalagay ka ng protection, tinatawagan mo eh. Now, if you do it so many times, magdududa talaga ang police. Kaya sometimes, your name reaches the list.

Pero it doesn't mean to say that you are a hardcore. Those are one of the things that are getting into the list, na innocently though, hindi mo akalain ganun.

But there are those na talagang nandiyan. Sabi ko, and to tell you frankly, I will not allow those policemen to go to prison if they kill you or the soldiers for that matter. Hindi ako papayag.

I will stake my Presidency, I go up and down. Babagsak ako on the issue of drugs. Kasi sisirain talaga ang bayan ko eh.

Kaya wala akong ano diyan na --- mga b\*\*\*\* naman rin 'yung... Alam mo 'yung 10,000. What was my 50th --- who was my 50th victim? Where did it happen? How did it happen? Masagot pa ba 'yan ganun?

You know, it's easy to accuse somebody. Pero, you know, guilt is personal. Whoever did it, it's his God d\*\*\* worry.

'Yung nagsabi sakín nag-utos ako, I'm doing it for my country. And why should they worry about my statements? It is a legitimate action.

Wala akong ano diyan na by my words. By my words what? Kaya hindi ako natatakot niyang pabalik-balik sila dito international court. Eh sige, maglaban tayo doon. Tingnan natin kung gaano kahusay ninyo.

It's not easy to accuse a person of a crime 10,000. You have to prove the 10,000 killed. Are you sure?

May namatay lang diyan, 'pag walang nakita, extrajudicial killing. At saka ngayon ang labanan hindi na 'yang ano ha, hindi na 'yang marked money, marked money. Wala na 'yan.

Pasa lang diyan, kunin mo sa ano, iiwan ng inter-city delivery. Tapos doon sa anong --- 'yung money na mag-ano ka, magpadala ka ng pera? Sa city, inter-city. Hindi naman tinitingnan 'yan eh.

Ang pera niyan bangko na lang, bank account, 'yun, delivery. 'Yan ang style ngayon, mahirap. The only way is really hiritan mo 'yung matataas. Hiritan mo 'yung mataas.

Wala akong ano diyan sa Ozamiz. Wala nang tumatakbo doon. Tumatakbo ka, patayin ka. Police ka, mag-supla ka, patayin ka.

Tapos may mga mansion kayo, ang wallpaper P500 denomination. Napaka-luod mo naman. P\*\*\*\*\* i\*\*. Dapat ka talagang patayin kung ganun, totoo lang.

It will be the same campaign. Hindi na ako pwedeng atras diyan eh, it's too late. 'Pag hindi ko nga nakontrol dito, I might as well go down.

I might --- sabi ko nga sa military nung nagka-prangkahan kami, "You oust me, you what? Coup d'état kayo? For what? Tell me. If I do not measure up to the expectations, to your standard, tell me and I will step down." Pero kung ako personally, it's not dependent on any --- ako mismo ang... Bantay kayo.

Sabihin mo 'yang police, hindi ma-dismiss 'yung kaso, alam mo ang gawain? Magpunta doon sa Crame, mag-kubra pa ng back pay ang mga p\*\*\*\*\* i\*\* niya.

Tapos sabihan, "Sige, i-process." 'Yung back pay niya, matagal walang trabaho, eh exonerated. When the case is dismissed on grounds of speedy trial, a violation of the Constitution to speedy trial, that is a verdict of innocence. And they can go back there and collect. Nakahirit na ng krimen and they would go back there to collect more from government. Bigyan mo lang 'yang opisyal diyan, okay na.

Ito sabihin ko sa inyo buti't nandito kayo. Itong ordinary station. Paguwi ninyo tanungin mo ngayon. Station 5? Presinto dos?

Every month meron 'yan sila liquidation. 'Yun bang pera dumating sa inyo para i-clear ninyo? Wala. Eh anong i-liquidate mo? Initiative na lang.

Ganun ka... It's how rot... Tanungin mo 'yung istasyon mo. Tingnan mo ang gasolina. Kaya tayo, kung hindi tayo magtulong doon sa gasolina, patay ang pulis hindi ka maka... In Davao, we give everything and you should. Huwag ka nang umasa diyan sa --- kulang man rin talaga.

Kaya ko dinoble 'yung sweldo nila, kulang talaga. But even then, even with doubled salary, talagang kulang 'yan.

Alam mo... Alam mo kasi, there's an aberration. There's an anomaly in the system. They retire at the age of 56.

If you reckon that, then they'd marry about 20 years, 25, 26, 27, 28, 30. Ang mga anak lang nila niyan nasa high school pa o kakaano lang sa college.

Kaya this has to be corrected. Ako, I recommend 60. Kaya lang 'yung mga matatanda, ilagay mo sa istasyon. Then 'yung mga bata, 'yan 'yung mga RSAF ganun.

Masyadong maaga mawalaan ng... Kaya... Ako kasi nagpunta nang kung saan-saan. Nagwallop ako sa overseas workers.

Kayo? Di man ako lumapit sa inyo. Walang ni isa sa inyo na sumuporta sa akin. Alam ko 'yan. Saan ako kumuha ng boto? Sa labas. And 'yung ano ko lang, tiyaga ko.

But I was carrying three messages. Baka makatulong ito sa inyo balang araw mag-Presidente ka.

Sabi ko I'll stop graft and corruption, drugs, and improve the economy by improving the law and order.

So ang corruption, talagang madali 'yan. There's less corruption now dito. Kung meron man, the latest that I fired was the Undersecretary of Budget namin diyan sa Malacañan.

Talagang sinipa ko. Li --- literally na sinipa ko talagang p\*\*\*\*\* --- tadyak. L\*\*\*\*\* ka, pati dito pati pera ng Malacañan, luslusin mo.

Tapos 'yung droga. Hindi ako makaatras diyan. Nanalo ako diyan. Ni wala akong barangay captain sa siyudad ninyo ni isa. Tapos sabi ko ito: Nanalo ako. Ngayon, ito ang tanong ko, makaatras ako?

Six million ang margin ko over Roxas. Makaatras ako sa sinabi ko sa ipinangako ko sa tao? You must be crazy.

Kung ano lang 'yung --- even during the presidential debates, I was the first to finish in my whatever elucidations.

Because it was only --- I carried the right messages. 'Yan lang talaga ang ano. And itong development, initiative ninyo 'yan.

Oh by the way, exception si [inaudible] taga-Davao man sila, and of course si Nograles. Pero outside, ni wala akong barangay captain dito sa Maynila.

Pero somebody told me "Mag-landslide ka dito, maniwala ka." Long before 'yung mga ratings. Three, four, sabi ko "Wala man akong pag-asa dito."

Ang sabi ng isang tao, alam mo 'yan? Si Alberto Romulo. 'Yung matanda, 'yung mga matanda na ano sa pulitika, sabi niya "Tandaan mo, manalo ka."

'Yung sa subdivision lang, eh nandiyan siya sa... I think he lives in Corinthians. So dito lang, nag-survey ako. Two --- eight out of two, eight iyo. But I was really...

Ito ang last, eh 'di nagta-travel ako. It's not rare that you find an OFW landing in the front pages of national broadsheets na nahulog, nagkasakit, binugbog tapos ni-rape. You know, ang pamilya kasi --- kapwa natin pamilya Pilipino.

Pag nag-alis ang nanay, nagtrabaho, this family becomes dysfunctional. Pag nag-alis ang tatay sa Kuwait, ang nanay sa Qatar, the family is no longer there.

liwanan 'yung mga anak sa lola, lolo, sa mga kapatid. 'Yan ang masakit, ang social impact.

Second, ito sila, and it is not also rare na mabasa mo ni-rape tapos marinig mo talaga 'yan. It's a universal complaint. Halos lahat na wala.

Ang pagkain nila, basura lang, wala silang tulog, ginagamit sila ng amo nila, ginagamit sila ng anak nila, pati 'yung son-in-law mag-extra. And they are supplied with... And yet they work.

Bahala na masira ang katawan nila makapagpadala lang naman, to remit money. And that includes the [inaudible]. So many thousands or millions are families here now dysfunctional.

Ang masakit kasi nito, kasi pinaano ko talaga 'yan... Intelligence. Itong mga ito, shabu is for the poor. So 'yung shabu, two ano --- 200 lang man ang sachet.

Sana pupunta na 'yan sa pagkain, maski ulam lang, kanin, magamit pati pamasaha na sa bata sa eskwelahan, 200.

Alam nila kung sino 'yung mga bata na may regular remittances na. 'Yung may ready money na maliit. Alam nila kung sino. 'Yan ang luslusin. Didikitan lang ng hanggang bibigay. Pagbigay niyan, humihirit na.

Magtanong ako sa inyo. Pabalik-balik itong droga kasi 'yan man ang trabaho niya. Anong hustisya ibinigay mo sa pobreng nanay pati tatay? Ganun na lang? Ganun na lang gawain mo tapos papayag ka nagkaganito ang buhay nila?

Nagpakamatay sila ng trabaho doon tapos pag-uwi nila, wala pala. And madadagdagan pa, sira ang buhay ng mga anak nila. Because of the dysfunctional family na iniwan nila.

Kung hindi naman nila iniwan, wala sila ng pera kasi mahirap ang Pilipinas. And if you are there at the top, it's almost crazy to think how you can help your fellow human being na hindi na ka sana mag ganito.

So that is the rage, kagaya sa Marawi. Itong mga human rights na ito, listen, national 'yon sa likod, mga TV.

There were about 30 Moro or Christians that were taken hostage as a cover by the Maute.

During their last days on this planet, they were raped, they were told to do things. Maglaba, magluto, gamitin. Kung sino-sino lang tapos ngayon, skeletal remains. Human rights, pu --- bakit ka tahimik diyan?

Kaya ito si Gascon, p\*\*\*\*\* i\*\* mo 'pag nakita kita, l\*\*\*\*\* ka. Better avoid we cross paths. P\*\*\*\*\* i\*\* mo, sampalin talaga kita, totoo lang. Hindi ko malaman kung bakla ka o --- either masipa kita o... Hindi mo naman ako mademanda. Sige daw 'be.

'Yun ang masakit sa akin. Kung kami dito, you don't even bother to find out kung sino ang namatay, bakit namatay? Bakit ka naman papatay kung wala kang kasalanan?

Eh aggressive, may baril talaga. Sinasabi ko na sa inyo kung ayaw ninyo maniwala kasi ano, itong most of all the lethal virulent one is shabu. Ako mismo, mayor ako, nakikita ko.

Umiiikot ako noon. Kilala man ninyo ako. I go out and observe what is happening. Bakit ako maghanap ng gulo? Why would I kill people for...? Ano ako, Mexicano?

"You know, my friend, I kill people for money. But since you are my friend, I'll kill you for nothing." Son of...

'Yan ang kunsumisyon ko. But if you really want na ano --- eh 'di pumunta lang kayo kay Secretary Año o kay General Cuy. General ito noon sa --- siya 'yung Chief of Police sa Davao noon, lahat 'yan sila dumaan sa Chief of Police.

Mabait 'yan, eh 'di kausapin ninyo then look into the records then find out why napasok 'yung --- and I'll be fair, and I will restore your police authority.

Pero ito walang takutan 'to ha, hindi ako nanakot because you can do it to me as I can do it to you. P\*\*\*\*\* i\*\*, hihiritan talaga kita, if I cannot get you near, I'll get you far.

Wala tayong lokohan dito kasi puro elected tayo. I have less control over you. But do not commit a crime as heinous as drugs, killing people innocently 'yung mga... Hindi ko talaga matanggap 'yan, hindi ko matanggap, honestly.

Magalit kayo sa akin okay na lang tutal wala naman rin ako. The reason why maybe I'm not so interest about 'yung magpupunta-punta sa lugar niyo, wala naman ako, tapos na ako.

All I want to do is just to work and work and work for the Filipino, kasali na kayo diyan. Magta-trabaho talaga ako. Magpakamatay ako ng trabaho para sa inyo.

'Yung iba naman huwag ninyong sirain ang bayan ninyo kasi marami dito na ayaw talaga. Mga pulis, hindi pulis durugista eh, pulis nga ang nagpapatay ng patay ng pulis eh, alang-alang ako pa.

'Yung mga ninja may patong sa ulo 'yang mga p\*\*\*\*\* i\*\*\*\*\* 'yan. Walang takers hangang ngayon kasi may pera eh. "Magkano ba offer ni Duterte, two million?" "O sige, 10 million kami sa ulo niya." Ako pa tuloy naalanganin ditong l\*\*\*\*\* ito.

Pero 'pag mag-abot tayo... And by the way mag-abugado tayo. For those people na sabi na pinapatay ko 'yung mahirap, like the guys of Tondo. Hindi ko naman sinabing mahirap ang mga tao diyan, more or less talagang magsabi ka poverty abounds or there about ganyan.

The crime of the business of shabu is always organized crime. It cannot be an independent activity na may mag-sigarilyo kung may traffic bumili ng Chiclet ganoon.

No. Shabu is distributed so therefore there has to be a cook and there has to be the distributors, the lieutenants and 'yung mga basurero, 'yung peddlers na doon, ganun 'yan.

The rule sa batas is if it's a conspiracy, like an organized crime, the act of one, the peddler na pobre and the cook na mapera, they share the same liability and the same punishment. Okay?

So when I tell the police, "Destroy the organization." It means destroy all. At 'pag ikaw ay nakita dito lumaban ka sa pulis, only if you're the police is --- the life of the police is in danger, 'yan lang ang test eh.

'Pag nakita mo delikado ang buhay mo, 'wag mo nang hintayin mabiyuda ang asawa mo. Hiritan mo na tutal itong p\*\*\*\*\* i\*\*\* 'to may atraso ito sa ating bayan, sa tao.

Kapa --- society, I forgot the --- anong Tagalog ng society? Lipunan. P\*\*\*\*\* i\*\*\*\* Tagalog na ito, maglipat tayo sa Bisaya. [laughter] Kapunuhan.

The act of one is the act of all. Tapos sabihin, "Si Duterte bakit niya pinatay?" Ay p\*\*\*. Ang oath natin is to enforce it against all.

Does not give a s\*\*\* whether you are a poor or you are a rich. Pagka organized crime pareho-pareho kayo.

'Yung sabi ng mga bleeding hearts, ng mga pari, obispo, "Pinapatay ang mga..." Ah p\*\*\* you study law. We --- when I enforce the law, I enforce it against everybody connected with that organization.

So even if you bleed your heart for the poor, you also bleed your heart for the i\*\*\*\*, 'yung nagluluto.

Ngayon, sabi ng punerarya, "T\*\*\* i\*\*\*\*\* Duterte na 'to puno na 'yung punerarya namin wala nang malagyan, walang nagki-claim ng..." Why do you think walang claimants? Sige nga?

Bakit napuno 'yung punerarya nila tapos sige sa reklamo wala nang malagyan kasi walang nagki-claim? Bakit walang nagki-claim? Kasi ang unang birada dito, atin-atin lang ito 'wag masyadong parinigin ang media diyan --- kasi hindi sila Pilipino. So walang nagki-claim. Sino sila? Secret. [laughter]

I do not want to spoil relations with... Walang nagki-claim eh. Pareho sa Davao, 1904 going 1905, New Year's eve. May alert na tapos ipinasilip ko precursors pa lahat. Kung mag-grade kayo niyan precursors that's not shabu. You're wasting your time.

Sabi ko, "You wait. Be patient." Naluto, nailatag na nila doon sa flooring, 720 kilos of shabu, luto na.

New Year's eve. Eh 'di madaling sabi, barilan, ay siyempre may barilan 'yan. Tapos sa galit ko inilagay ko sa highway, siguro mga alas kwatro 'yun, inilagay ko sa highway so 'yun trapik doon sa south galing Sta. Cruz, 'yun na kasi tumitingin eh.

Alam ko si Dureza 'yun, si Dureza ganon talaga eh. "Ma'am, si Lito nag-a-ano na 'yung anim na patay gi-display ni Duterte diyan sa highway. Trapik, ano na pati malangaw."

Tawag si --- buhay pa naman 'yan si ma'am, "O Rody, bakit ka naga-ano diyan ng patay?" Sabi ko, "Eh hayaan mo 'yan ma'am, para matuto itong --- 'tong mga p\*\*\*\*\* i\*\*." Since then wala na kami.

Wala na kaming problema sa luto-luto? Tapos kinaumagahan may mga nagdating kasi kunin 'yung patay, sabi ko, "Where's your --- where's the passport? So where are your papers?"

Walang maipakita kasi ang passport nandito sa akin. "Nasaan 'yung passport?" "Wala." No. Tapos 'pag hapon, "Can we cremate? Maski 'yun ashes?" Sabi ko, "No. No passport, no cremation."

Alam mo sa totoo lang --- nandiyan 'yang anak ko Mayor 'yan, 'yung mga patay ibinigay ko doon sa Davao Medical Foundation, school of medicine doon.

Kasi I remember, sige lang sila hingi ng patay walang magpabili. Alam mo ang Pilipino maski gaano kahirap, sabihin ipagbili mo 'yung katawan tapos pagpraktisan?

Tinawagan ko 'yung head ng eskwelahan, "O, dito kunin mo, sa punerarya dito sa Toril. Preskong-presko ito ang sugat nito sa ulo lang. Isang butas 'yan, praktisan ninyo 'yan, pati b\*\*\*\*\* niyang mga p\*\*\*\*\* i\*\*\*\*\* 'yan."

Meron diyan, kung anak mo mag-aral ng medicine sa Davao maabutan pa niya 'yang u\*\*\* na 'yan.

Sino man dito? Media. Sige marami patay na umaapaw na doon sa punerarya, walang kumukuha? Eh hindi naman 'yun Pilipino. Sino? Mga taga-Somalia siguro 'yon.

Ganito, I'm just trying to --- I'm not delivering a speech actually, I'm having a dialogue with you para magkaintindihan tayo.

Please, avoid it. Please, avoid it. I really do not want to do anything violent. Let's just stick with our oath of office at protect --- kung kayo napasubo, if you are --- kayo ang nakapatay ng --- kayo ang --- I'll be there.

Huwag kayong magalaala, ako ang may hawak ng alas dito. Ako ang may hawak ng alas. Walang iba, hindi 'yang Supreme Court, wala 'yan; Congress, wala 'yan; Human Rights, wala 'yan. Trabaho lang kayo, ako ang bahala.



Prosecution? O sige, magpademanda kayo. Demanda, Ombudsman, demanda? O sige. Silbatuhan mo ako, "Sir, demanda..." Tanungin kita, "Ano 'yun?"

"Eh, sir, dahil nung 'pag raid namin o meron kaming ginawa." O project na --- 'yung harassment, "Sige lang, okay lang."

Trial? Sige lang, maski magkuha ka ng bobo na abugado na hindi pumasa ng Bar, sige. Trial, tapos sentencing, judgment day, o paalamin mo ako, "Mayor." "Ano?" "Reclusion temporal man." "P\*\*\*\*\*!\*\*, totoo ka? Ano nga 'yung pangalan mo?"

You prepare a --- absolute pardon, restored to full political and civil rights. Eh 'di tapos ang istorya. [applause]
