SUBJECT : BIDS AND AWARDS COMMITTEE (BAC) DECLARING AS SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO SOLID VIDEO CORPORATION (SVC) ON THE PROCUREMENT OF GOODS FOR THE RENTAL OF TECHNICAL SUPPORT SERVICES AND BROADCAST EQUIPMENT INCLUSIVE OF SUPPLIES AND MATERIALS DELIVERY, INSTALLATION, INTEGRATION, TESTING, COMMISSIONING, ON-AIR TECHNICAL SERVICES AND PRODUCTION MANAGEMENT SERVICES FOR THE INTERNATIONAL MEDIA CENTER (IMC) FOR THE 31st ASEAN 2017 SUMMIT

WHEREAS, the Presidential Communications Operations Office (PCOO) through the 2017 General Appropriations Act of the Presidential Communications Operations Office (PCOO), pursuant to Administrative Order No. 48 creating the National Organizing Council (NOC) for ASEAN 2017 intends to procure for the Rental of Technical Support and Broadcast Equipment inclusive of Supplies and Materials, Delivery, Integration, Testing, Commissioning, On-Air Technical Services and Production Management Services for the International Media Center (IMC) for the 31st ASEAN 2017 Summit to be held on November 10-14, 2017;

WHEREAS, the PCOO-Bids and Awards Committee (BAC) resorted to competitive bidding pursuant to Section 10, Art. IV of Republic Act 9184 (also known as "The Government Procurement Reform Act");

WHEREAS, on September 29, 2017, an Invitation to Bid for the procurement of the above-mentioned Project was posted on the PhilGEPS website as required by law;

WHEREAS, only one (1) company, SOLID VIDEO CORPORATION (SVC), submitted a bid, and after bid evaluation was conducted, SVC was declared to be the sole bidder with the Single Calculated Bid (SCB) in the amount of THREE HUNDRED FIFTY-THREE MILLION PESOS (PHP353,000,000.00);

WHEREAS, on October 23, 2017, the members of PCOO-BAC TECHNICAL WORKING GROUP (TWG), in order to ascertain the statements and validate the documents submitted by SVC, conducted a post-qualification evaluation using the "pass/fail" criteria and declared SVC as a sole eligible bidder for the contract;

WHEREAS, pursuant to Section 34.2, Rule X of the 2016 Revised Implementing Rules and Regulations of the Procurement Act, SVC was issued a Notice by the Bids and Awards Committee (BAC) as the bidder having the lowest calculated bid price and






NOW THEREFORE, having considered the foregoing circumstances, the PCOO-BAC unanimously resolves to declare the bid of **SOLID VIDEO CORPORATION** as the **Single Calculated Responsive Bid (SCRB)** and to recommend to the Head of the Procuring Entity (HoPE) the award of the contract in the amount of **THREE HUNDRED FIFTY-THREE MILLION PESOS ONLY (PHP 353,000,000.00)**. The corresponding Notice of Award and Notice to Proceed will be issued upon approval of the contract by the HoPE.


BE IT RESOLVED, as it is hereby resolved, at the PCOO Conference Room, New Executive Building, Malacañang, San Miguel Manila.


