#### **President Rodrigo Roa Duterte**

#### **During The Hugpong Ng Pagbabago Convention**

[Delivered at SMX Convention Center, Lanang, Davao City | 17 August 2018]

Kindly sit down. Thank you for your courtesy.

The officials and members of Hugpong ng Pagbabago, led by Davao City Mayor Sara Duterte-Carpio as Chairman, Chairperson *[applause]*; Governor Claude Bautista as President, Governor --- President; Governor Nelson Dayanghirang as Vice President; Secretary General Anthony Rafael Del Rosario; and National Treasurer Governor Jayvee Tyron Uy; Presidential Spokesperson senator Harry Roque, palakpaki pud. *[applause]*

Now, if there is any person na hindi ko kapartido, 'di kapartido, eh partylist 'to eh tsaka maingay, 'yun ang gusto ko. Actually the reason why... Tonyboy, you seem to be at peace already. *[laughter]* *[Nianhi ba si Bebot? Nia si Bebot?Wala?]*

If there is any person that I appreciated for honesty and just exposing anomalies in government, kaya ko napag-isipan na kunin ko si Roque. Kasi gusto ko 'yung tao --- marami ako kinuha diyan na medyo not really for me but did not campaign against me.

So sinabi ko sa kanila, "If you are available I'd like you to join the government." Kasi alam ko, one time lang ako eh. And I would be hitting the firewall three years from now. I don't expect to live that long. Insha'Allah. Insha'Allah.

But if I get there, I would like to leave government in the hands of Filipinos who simply love their country. Ang importante kasi, ang different intensity pati love. While others get swayed away with lahat na.

Kaya una --- you know, I was frustrated. But remember that I was addressing myself to the military and the police and nobody else. Iyong narinig ninyo was an afterthought, actually 'yung mga comments.

And I was exasperated. I was busy fixing the Nayong Pilipino. And of course, they were all my friends. That's why dumating sila eh, doon sa opisina na `yun.

And here comes the military, binubulungan ako ngayon niyang opisyal na, "Mayor sorry pero may..." Alam mo mapatawad kita kung magsabi lang ng overpriced. Pero `yang medisina sa sundalo or any patient, Filipino for that matter na mag-asa na mag-inom na mag-inom, naghihintay ng medisina na wala, ay p\*\*\*\*\* i\*\* talagang puputok ako diyan.

I was so exasperated. Hanggang kailan ba `to?P\*\*\*\*\* i\*\* nakakasuka. That's why during the command conference, I was not addressing to these idiots outside. It was a pure military affair. It was a command conference.

Sabi ko, kung ganito lang naman, bakit ako magsakripisyo ng ganito? Matanda na ako tapos araw-araw may ganito. Paano ko habulin itong p\*\*\*\*\* i\*\* kaloko...

Pati medisina s\*\*\*\*\* mo pa. Iyong iba, na-okay na ako diyan sa mga hardware, hardware. But medisina. Karami kong pulis pati sundalo na tinamaan diyan sa --- almost mga 3,000 tinamaan.

And ang --- the irony of it all is that I am giving PGH 100 million. Kasi maraming ilang beses pumunta doon at sinabi sa akin at may pagkukulang talaga. It's about mga --- they get 26 million per year, medisina.

And it came to my attention na pati `yung mga interns, mga anak ninyong nasa UP and you try to check them out, sila na mismo ang nagko-contribute kasi ang pobrang Pilipino walang pang-medisina.

So what's that 26 million, what a year? So when they went to my office, I said, "How much do you need?" "Sir, siguro if you can add another 40 or 50, that would be --- that would go a long way to help alleviate the..."

Nandiyan `yung mga doctor na Pilipino, the bright and the brightest diyan. Karamihan diyan UP. Hindi naman sabihin na sila ang --- ang UP ang pinakamahusay. Pero that's the training ground for UP students na kumukuha ng medicine. All others, okay man din. Pareho lang `yan `pag doctor.

`Pag hindi marunong ang doctor mo, patay ka. `Pag marunong, buhay ka. Ganun lang `yan. So sabi ko, "If I give you 100 million, can you improve the lives of the Filipino --- the poor Filipino?" Sabi nila, "Sir okay `yan masyado."

Sabi, "Yearly?" Sabi ko, "No. I'll give you 100 million a month just take care of the poor Filipino. [applause] Tulungan lang ninyo 'yung mahirap."

And the irony of it all, is that itong, itong --- the general that I fired. Also asked for the same amount, same privileges, 100 million. P\*\*\*\*\* j\*\* kung pumayag daw ako, 'di 100 million a month, bilyonaryo 'yun, isang taon lang.

And all others I said --- no, no, no. Sabi ko kay Galvez, "You fire them tapos have them court-martialed para ang kaharap niya kapwa niya sundalo. He will be facing his peers. Doon siya tumingin siya tumingin sa mata sa mga taong niloko nila. Mag-martial law --- i-martial mo 'yang y\*\*\* na 'yan."

Iyon namang sa --- they corrected me though. But I stand firm by the records. As of now, hindi siya maka-account ng 15 million.

Alam mo 'yung mga kadete, may mga honorarium 'yan. Eh wala namang mga pera 'yan, karamihan ng mga sundalo nga natin pareho rin sa atin eh, galing sa hirap na pamilya.

But they had the best and brightest of the Filipinos, so they are there. Meron 'yan silang allowance, pang-uwi, weekends or whatever. Iyan hindi nabigay 'yan. Accumulated to something like --- 'yung mga iba diyan narinig ko... Ito, huwag talaga akong mag --- mag-aaway tayo nito.

And I said to them, "Ano kaya gusto ninyo mag-resign ako ngayon? I am challenging you, every one of you to --- kung sinong interesado, just stand up. What's the --- stand up and sabihin mo."

If ang Air Force, Navy, Marines, Police, lahat kayo major commands magsabi, "Bumaba ka." Fine. P\*\*\*, mas pagod ako sa inyo. And kayo sabi ko, because I will --- you will, after I shall have stepped down, magulo 'yan. Magulo 'yan kasi sabihin nila --- now let me just disabuse your mind. I am not doing this because I'm afraid of the military, I'm afraid of the police.

You know, I was elected by the people. Iyong military, may trabaho sila gawin mo. Iyong police, hanggang karami pang kalokohan, you better shape up because I will rise and fall sa issue ng corruption. Ang police maraming atraso. P\*\*\*\*\* j\*\* kayo. Sinabi ko na sa inyo, tama na eh.

But I think 'yung nag-sige kidnap, kidnap dito, either it's the ninja police or ito talagang scalawags. So the good practice maybe sa ninja cops, I will now raise the amount of five million per ninja cop. If you bring him to me dead, I'll give you 500,000, no questions asked o three million. Kung medyo ano

lang, ewan ko. Pero kung dalhin mo 'yan sa akin patay, 5 --- 500 --- ah five million. 'Pag buhay, bigyan kita diyees mil. *[laughter and applause]*

O kagaya mga pulis diyan, kung ayaw ninyong pumasok ng masama ito legal 'to. Wala kong sinabing patayin mo pero dinala mo buhay, bigyan kita diyees mil, masipa pa kita paglabas mo sa... *[laughter]*

Pero kung --- totoo ha, hindi ako nagbobola. Hindi ako kagaya ng iba man. 'Pag sinabi ko publiko, totoo 'yan. Five million sa ninja cops. Surrender within 48 hours. Kasi 'pag hindi kayo nag-surrender, dadagdagan ko 'yan one million per month hanggang ang asawa mo maghanap ng boyfriend diyan na papatayin ka. Tootoo.

Eh ganun ang gusto mo eh. May pera naman ako, eh 'di gastusin ko. Tatal nakikita naman ninyo 'yung pera ninyo, dinadala ko --- ayan o. Paghati-hatian niyo for operations and intelligence gathering.

Ganun ako sa kanila nag-ano. Bag talaga mismo 'yung pera diyan o. Hatiin ninyo pagkatapos, pag-alis ko. Hindi ako 'yung sabi mo na ganito. Ito 'yung inyo sa intelligence fund. 50 million for this month. O sige paghati-hatian ninyo.

O kayo, mga pulis na matino, mga --- kung may --- kasi kayong mga pulis tig-dalawa, tatlong asawa ang mga g\*\*\* akala mo haciendero. Maghanap ka ng pulis diyan namatay na isa lang ang pamilyang umiiyak, milagro na 'yan. *[laughter]* Tootoo. Ang sarap suntukin nitong mga buang na 'to.

Pero hindi lahat. May scalawag lang. And there's the reason why sabi nila, "Eh bakit sa panahon nila --- past --- lalo na 'yung sinundan ko, wala man lang namamatay, wala namang pulis na..."

Kasi alam ninyo --- kayong municipal mayor, you know that. The only way na may laban sa korte ang drug pusher, drug dealer is to file a counter charge.

'Pag mag-counter charge na, ang pulis walang abogado, walang pera, mapipilitan 'yan. Kayo lahat kasama ko kayo noon, fiscals. I was once a prosecutor of this --- for eight years, I was a trial prosecutor.

Ang pinaka-madali --- ay 'yung mga abogado nandito. Huwag na tayo magbolahan. Mag-file na counter charge. Eh masugatan lang dito ganun, walang taong nag-surrender sa police na surrender diretso-diretso.

Maglaban talaga 'yan, lalo na 'yang mga bata. Pagkatapos pagdating doon sa istasyon, magtawag ng doctor, may garas dito, certificate of...

Kaya ang pulis, once the case is filed in court, that day he loses the income. His family goes to a hungry stage of their life. Ang mga bata, hindi na makapag-aral. Kaya ang pulis noon takot. Tapos meron pang mga police generals na sabit sa droga.

Huwag kayong maniwala niyang mga writers na --- ang kalaban lang nila ako kasi hindi nila ako masikmura. Eh kung hindi nila ako makasik --- eh pareho kami.

Iyong ganun, 'yung akin maglamano ng babae tapos --- ganun man talaga ako.

Nagla-landi. Pero hindi 'yung landi na bastos. Pero kung may gustong humalik sa akin dito ngayon... *[laughter]* Mamaliin nila, tingnan mo. Halika *[Medi?]* mag-halikan tayo dito. *[laughter]* Oo, maski sino. Eh maski lips to lips lang naman 'yan. *[laughter]* Sanay man tayo diyan.

'Yan ang problema diyan. Ngayon, ang pulis sa panahon ko nagtatrabaho at hindi natatakot kasi sabi ko sa trabaho --- in the performance of their duties or in the fulfillment of their mandate, masiguro kayo nasa likod mo ako. Huwag kang matakot pumatay, lumaban, arestuhin mo because the rule is when you make an arrest, you announce your authority, "police 'to." And the duty of the criminal is to surrender peacefully.

Ngayon, kung tatakbo siya, habulin siya, magkarambola kayo diyan because the rule is when you arrest a person, if there is a resistance, you have to overcome him. Pilitin mo talaga, sipain mo --- kasi you have to bring him into the folds of the law para madala mo sa jail at mademanda mo.

Eh kung lahat ngayon maglaban tapos takot ang pulis, magkabukol-bukol pati ang pulis may bukol, patay pa minsan. How many do you think my --- ilang pulis ang pati sundalo ko namatay ngayon?

Remember sa Marawi, it started with a service of a warrant of arrest. Pagdating ng pulis, pinagbabaril sila. Pumasok ang baril. It's *[nine?]*. Patay lahat. Puro sniper eh. Eh kung pareha nitong SM na nandiyan ka sa bintana tapos naglalakad ang Marines, kaya marami tayong losses.

How many died there? It was not a plain simple rebellion. It started with the service of the warrant to arrest. So that precipitated the fight.

But ngayon ako, admitahin ko, we fell short. Alam namin nagpapasahan na ng baril. Pati `yung mga pinsan ko sa Lanao del Sur nagsusumbong na na ang baril is freely given to anybody who would like to have it.

Ang hindi ko naagapan and I take full responsibility being the Commander-in-Chief, `yung pinakamaraming bala na-stock nila. So nag-abot ng halos limang buwan, with plenty of soldiers dead.

Akala lang kasi nila ito, ilan ang namatay doon? Ilan namatay na sundalo doon? Ngayon nga araw-araw may namatay ako dalawa, isa pulis. Ngayong araw na ito sigurado ako may namatay na pulis. Pusta kayo?

Isang libo mo manalo ng diyos mil sa akin `yan. Hintayin natin maya.Tingnan mo `yang, tingnan mo `yang nasabat shabu five million, nasabat na shabu 15. Dito sa buy-bust may patay.

Ang shabu noon was a million pesos transaction. Dito ngayon, billion. Kung billion `yan, ibig sabihin may market. Sino ang market diyan?`Di `yung mga anak natin, `yung mga Pilipino estupido.Alam nila masisira ang utak mo, papa --- napakahina naman ninyo.

I'd like to address myself to the nation, to all Filipinos listening who are not yet there. Masyado ka namang bobo.P\*\*\*\*\* j\*\* papasok ka ng ganun tapos magiging g\*\*\* ka.

I mean wala akong bilib sa inyo. Either napakahina ang utak ninyo, prinsipyo ninyo.Kaya dapat kayong mga babae huwag kayong magsagot ng mga lalake ganun.Inutil `yan.Ibig sabihin duwag `yan at madali madala.

Kung asawa mo pa, iwanan mo. Dito kay [*unclear*] o, kasi naghanap ito ng tatlo pa. O si Bato kasi senador na --- it's the vogue.

They pronounce it the "vogue." It's the vogue or the fad na pagka-senador ka, pwede ng dalawa kay sikat naman. Senador, bilib ako sa'yo. [*cheers and applause*] `Di ang sisi nito --- alam mo si Bato, he came here in Davao second lieutenant lang `yan. Nung kinasal, ako ang ninong. Ganun ko katagal dito. Over the years, na-assign dito matagal tapos na-assign sa Maynila, outside sandali, tapos bumalik. Siya talaga ang pinili ko. Now it was not meant to derogate the ranking sa pulis pero `yang posisyon na `yan napaka-delikado.

So kinuha ko talaga siya from dito, from one star to five star --- ah four star. Baka magka-de malas pa, five star ito, commander-in-chief itong...

O `di alam mo na problema mo --- patayin mo `yang police mong p\*\*\*\*\* j\*\*\*\*\*... Buwisit. Kaya na-buwisit ako. Sabi ko, "Ano ba `to, wala nang katapu..." Eh kayo mismo inaasahan ko eh. Pinagmamalaki ko. Tapos he [*inaudible*] this f\*\*\*\*\* --- medisina. Kaya ko talagang...

Iyong mga spare parts lang medyo malunok ko pa `yang mga ganun, medisina. Paano mo... Paano ang infection ng mga tao ko diyan? Tao ko `yan. I said, my troops, my policemen kasi ako ang commander-in-chief. So responsibilidad ko every tao. Whether they like me or not, I have to take care of them.

That's why in times of crisis... In Marawi, I went there nine times. Nagte-take off kami ni Bato doon gabi na. Sabi nila, "Sir, sitting target ka." "Ah hindi man `yan matablan si Bato. Take off tayo. Maniwala ka diyan."

Totoo, nagpunta ako hanggang gabi eight o'clock. Sabi nila, "Huwag ka mag-take off sir kasi klaro kaayo caliber 50." Sabi ko, "Pag hanggang dito lang tayo, hanggang dito lang tayo."

Sabi ko pa, "Nandiyan lang si Bato. Mauntol man `yung ano, bala." [*laughter*] Hindi man `yan ma... Ka dako'g lawas ana o, madutlan ba na? (He's so big. Do you think a bullet can get through him?) Kaya nga siya sinasama ko kay para pang-cover. [*laughter*]

Pero I'm telling you --- hindi ako nagpa-ano, nag-ambisyon niyan. During the time that he was there, he attacked us and I --- wala akong ano. Basta totoo lang nangyari because I will investigate. Because sinabi --- I can assure everybody here and everyone outside of this auditorium. Wala talaga kayong masabi sa akin because I do not allow transactions in government, `yung papers aabot sa lamesa ko. It starts and ends sa Cabinet member.

Ang dumating lang sa akin mga policy, mga central bank, appointments of diplomats, itong promotion, itong promotion police pati army. I-promote mo `yung isa, `yung sunod mag-promote, `yung isa ma-promote so hatak lahat `yan.

So `pag i-promote mo itong, kay nag-retire na isang general, `di bago, akyat `yan lahat. Ilang pirma `yan? Hanggang doon sa Tawi-Tawi angat `yan sila. Ako naman pirma nang pirma, nag-kaging (stiff) na ko. Dito ginagamit ko, ganun. Pero ako magpirma, pangalan ko talaga. Pareho kami ni Marcos. Iyong makita mo --- kung amin talaga because sinusulat namin `yung pangalan namin. "Marcos" makita mo. Ako naga-pirma talaga ako.

May isa ditong general, iba-iba ang pirma. Mabasa mo talaga, `yung iba mga tsuk-tsuk-tsuk-tsuk-tsuukkkk tapos `yung tsuk-tsuuukkk-tsuk-tsuuuuuk-tsuuuuuuk. *[laughter]*

Alam ninyo `yan. Iyong mga tamad na l\*\*\*\* magpa-arte, `yun. Iyong iba naman maliit, `yung babae ganun tsuk, tsuuuuuuk. *[laughter]*

Itong general na ito, alam niya kung sino. Sabihin mo si general na ito Bong ha, katamad niya. Sabihin mo, kung makita ko `yang papel niya itapon ko `yan. `Pag-ano niya iganun niya. Tsuk-tsuuuuuuk. *[laughter]*

Kami ni Marcos pati ako, we take the pain of --- you know. Mmmm-mmmm-mmmm-mmmm. Ito sa kanila --- i-point, parang period. Tsuk-tssuuuk. Parang, parang si...

Meron... Diyan ako natutuwa sa mga pirma. Sabi ko, tingin ko. Makumpyansahan ko kayang itong buang na ito. *[laughter]* Kasi babasahin mo `yung --- binabasa ko `yung utak kung ano eh. Iyong --- ang haba parang train. Ah ito hindi ko ito ilagay sa Mindanao Railway. Ubos tayo dito. Nag-aambisyon ng train. Hala. *[laughter]*

So `yan naman ang ano sa akin. Eh ano daw ako sa babae? Ang totoo niyan ganito. Sabihin ko na sa inyo. Eh kasi itong mga g\*\*\*, maghalikan ng --- ano ba naman `yang halik, bulgar. Kasi malisyoso kayo. Pwede siguro maghugas kayo uli. Your mouth.

Mga surrenderees ng NPA, so inisa't-isa ako. Diyan sa Malacañang. Nakita ko itong isa. Sabi ko, "Ilang taon ka..." Nandiyan `yung mga military o. Tanungin niyo, "Ilang taon kayo sa kalihukan (movement)?" "Seventeen years. Seventeen years, kaming dalawang mag-asawa. Ito nga `yung anak namin diyan sir, iniwan namin ito one year old."

Kaya ako sabi ko, "Ikaw?" "Sir hindi pa ako nauwi, ewan ko kung patay na ba `yung anak ko o buhay pa." Sabi ko, "Por Diyos naman kayo." Think of the human being, huwag na `yang anak ninyo. Maawa ako sa tao. Sinabihan ko `yung mga amazona, puro may anak. Sabi ko, "Ipabaril ko `yang p\*\*\*\*\* ninyo sa..." Eh totoo naman. Sige kayo mag-rapapap kayo tapos mag-iwan kayo ng anak, mag-laki ang bata walang nanay, walang tatay. Hindi alam kung patay na o hindi.

Iyon ang --- that was the narrative. Ganun talaga ako magsalita. Alam naman niyo. Hindi ako nag --- hindi ako naggamit ng... O... P\*\*\*\*\* ang sinabi ko. P\*\*\*\*\* ang sabiko, sige kayo anak. Para ma-overemphasize ko na huwag ganun. Huwag kung papasok lang naman kayo sa kalihukan, why



do you have --- mandadamay ka ng ibang tao sa mundong ito. Naaawa ako sa tao, period.

Eh `yung ano mga --- sabi daw shoot in the... They used it v\*\*\*\*\*. Wala akong sinabing... Napaka-malisyoso na --- sabi ko...Mabaho siguro ang ano ninyo. Maghugas kayo uli.

Never --- ang military o. There's a recording to it because there were networks covering the event. I never said na --- gawa-gawa lang `yan nila ng word, they're using...

Kagaya ng --- you know the usual, that's a slangeh. Son of a b\*\*\*\* is a slang. Kagaya ng sa atin `yan p\*\*\*\*\* j\*\*.... Slang `yan.

Iyan ang tinatawag --- hindi `yung... Kasi Pilipino pagkaintindi nila sa slang `yung, "You know, I'm just like talking about Yasay and I just came from the United States and I had to talk with the people of the State Department, sir and this is what happened, I opened..."

Akala nila `yung [drawl?] `yung --- [garbled] that's a [drawl?] or an accent or what. Iyong sabihing slang, slang is a dirty word. Sa atin, "P\*\*\*\*\* j\*\*", ano `yan `yung commercial ano --- street fighter. Iyon ang naglabas na evolved, those are slang words. Iyan, hindi `yung --- slang has nothing to do with the pronunciation. Marami kasi akong marinig na slang and it's not. It's --- it's the wrong usage of the word.

Kaya sinabi ko kay... Biro mo naman si Obama, pinagalitan ako sa press con. Sabi ko, "P\*\*\*\*\* j\*\*\*\* `to. Pareho kami Presidente tapos ganunin niya ako." Kaya sinabi ko, "Shut up. You son of a b\*\*\*\*. You go to hell."

Ang "son of a b\*\*\*\*" sa atin ay "p\*\*\*\*\* j\*\*".Alam mo ang ginagamit ng --- `yung magsisira, "son of a w\*\*\*\*\*." Eh bastos talaga `yung w\*\*\*\*\*. W\*\*\*\*\* is p\*\*\*. Iyang "son of a b\*\*\*\*" `pag magalit ka lang. May magsabi, "she's a b\*\*\*\*." Iyong `pag ganun masuya ka sa babae, sabihin mo, "She's a b\*\*\*\*." Careful, she's a b\*\*\*\*. Pala-away, palahingi, pero not necessarily `yung word na w\*\*\*\*.

Pero sinasadya nila `yan. Kasi ang Amerikano ayaw sa akin. Ngayon sa newspaper, buti't napag-usapan. We have been warned not to buy submarines from Russia. Kaya ang sagot ko sa kanila ganito: You meet me in a forum like --- and I will invite everybody interested. You state your case why you are against my country acquiring submarines. Give me the reason why and make it public. You want us to remain backwards. Eh ang Vietnam may seven, Malaysia has two, Indonesia has about eight. Tayo lang ang

wala. Hindi naman ninyo binibigyan kami. You sold us used NATO helicopters, refurbished. Just like an American transaction, nakikialam 'yung mga brokers ninyo. You sold us six helicopters. One or two or three crashed already. Killing the last one. All the crew member.

Is that the way how you treat an ally? And you want us to stay with you for all times? Eh bright man kaya kayo. Nandiyan 'yung mga Harvard ninyo. Think about it. Why did you not stop the other countries the --- Asia? Bakit kami pinipigilan ninyo?

There's a newspaper in Bulletin --- were warning us. Who are you to warn us? Pinagbili na nga siya --- nadala na nga. Kayo ang magbigay ng submarino? Magi-implode 'yun. What do I say by implode? Doon sa --- manggaling ang putok sa loob. Just like the helicopters you sold us.

Did you investigate that two or three of them crashed already? The latest was in Lipa. Kaka-take off lang, bumagsak, pumutok. Galing sa inyo 'yun. Refurbished NATO helicopter. Tapos... No, no, I'm not your enemy. I'm protecting my soldiers and police.

Diyan tayo mag-away on that principle that... Why, what's the problem about acquiring submarines? We are not using against you, neither can we use against China or anybody else because we are under armed.

Nakatingin ako sa TV kasi gusto kong i-emphasize sa mga Amerikano, may mga CIA ngayon. Ang balita pa gusto nila akong patayin. Go ahead. Be my guest. After all, this country will remain the way it is if [*inaudible*] all the leaders.

Kaya 'pag pumutok 'yung helicopter ko diyan. Sila 'yan. They're the only one interested to... Ayaw nila ito, ayaw nila niyan. Buot-buot, p\*\*\*\*\* i\*\*. Wala namang binibigay sa atin. At mind you, lahat ng kinukuha natin sa kanila hindi for free 'yan. Bayad 'yan.

Ang Korea pati Japan ang nagbibigay ng libre. Gratis talaga. And China, and Russia. To this... Bigyan mo nga akong scotch para mag-init ako ng...

To this day, ang China or Russia never asked us even for a paper clip. Wala siyang sinabi na about the West Philippine Sea, ako pa nga 'yung nagalit eh.

You know, when you create an artificial island I think that it would be... Ang sabi ko sa China, 'yung sabi niya, "Filipinos. Go out of..." You cannot create

islands there and claim the sea. That is not an island. Artificial islands are not pro --- are prohibited in the middle sea. Iyan nga ang rule diyan eh.

Just because we are friends, huwag mo na kaming --- "Filipinos. Go out there or that is your responsibility if anything will happen." Alam naman --- you know very well that we will not attack anybody there. And we are a claimant of the group of islands.

And we are not --- I told you we are not prepared to go to war with you, so why do you have to say those nasty words? There's no need for that. We are your friend.

America, because of Trump, he's so good to me. I will ask him, "Mr. President, what's wrong in..." If I get to see him --- he's been inviting me to go to America.

America has a hydra. Dito, si Obama insultuhin ka, dalhin ka doon sa ICC para --- para kang kriminal. You will know why the Western EU --- EU... Complete the sentence for me. Pa-bright, bright kayo diyan, mga bugo... Maniwala kayo diyan sa mga EU, EU. Threatening us with trade sanctions. Go ahead. But we will place it in our hearts someday.

You criticize us --- in the year 1912 to 1917, you started a ruckus, first World War. Kayo diyan sa European ang nagpatayan. 15 million Europeans died. Ngayon, pumunta kayo dito, mag-criticize kayo sa mga kriminal without even the specification. 4,000 dead. You're --- you're always guessing. Basta may nakitang patay diyan, extrajudicial killing. And why publish only 4,000? Who are they? Who are they? May CIA ba dito? Iyong intelligence may nakita kayo? Sampalin kita diyan ngayon.

Baliktarin mo. Sino 'yung mga biktima nila? Historically, dito sa Davao and the rest of all the Philippines. Iyong katapusan 'yung Tano --- Ombudsman prosecutor na buntis. Pero sa awa ng Diyos, 'yung nagpatay sa kanya, patay na rin. Tabla-tabla lang. Pati 'yung nag-rape dito na dalaga diyan sa --- 'yung pupuntang Toril about five weeks ago, patay na rin. Sabay-sabay na tayo sa langit dito.

At bakit ko naman... Sinong gustong --- sinong gustong puntang langit?Wala. Kasi lahat kayo makakasalanan. Lahat dito may racket talaga. At one time in your life may racket kayo, sigurado 'yan.

Women? Ah, maya na. Ayaw kong bastusin 'yun. Sabihin misogyny. May sikreto ako na sabihin sa inyo, kayong lahat guilty. So that's really the...

Now, let's go to governance. I appreciate what Inday is doing, even to galvanize the Filipino people, matignan ninyo ang sitwasyon.

I would like to be very, very, very frank with you. Philippines still ruled by money. Every political groupings, meron talagang --- hindi ko na pa... There's the shipping magnate, there's the enterprising, lahat. Alam na ninyo, hindi ko na sabihin baka --- basta `yung traditional.

Ang grouping ng PDP, hindi talaga nag... I do not want to make anybody uncomfortable here. Pero mabuti `yung maprangka-prangka. It never grew ang PDP. It even outlived the --- `yung mga talent nila. Why? Because of money. It's a principled party, I know. And I use it as a --- my platform to run for the presidency.

Pero kung sabihin mo pera, partido. So my advice is if you're comfortable with your mother unit, you might want to continue and coalesce with PDP-Laban.

I'd like to be very frank with you. Hindi pwedeng `yang tawag ng... "O ano, Mr... Pwede bang tulungan mo `to?" That's the usual practice. "Tulungan mo itong..."

Ako sabihin ko sa iyo, "No way." No way akong mag... Ang isa diyan, to the last day sa elections. He was at the airport waiting for Bong to pick up the money. Sabi ko sa kanya, "No." Buti't na lang. So hindi ako.

But if you want me to campaign for you, I will. Walang problema `yan. Money, you can go to your original --- Let's have just a coalition. Pero ngayon man, nobody but nobody really, not even a congressman can claim na sinolo (solo) ko sa Davao. My orders were only --- spread it evenly sa lahat ng probinsya pati siyudad. Huwag kayong mag --- do not play favorites.

Walang naka-ano... `Yung mga --- sa maririnig niyong mga train-train, gratis `yan. They just want to build it, give you about 30 years, the extension of 35 years, that's forever. And that's also the rational or rationale why I fired `yung lahat ng board members ng...

Just imagine, ang draft niya --- it does not really matter, it's the final --- it was not final. Pero `yung draft niya nakita ko. Ka-abugado mo, 75 years sa Nayong Pilipino? G\*\*\* ka ba? That's why I fired Jurado. Anak siya ng acting professor. Si... Oo. Professor natin `yan, karamihan natin dito.

Imagine, 75 years. Sabi ko sa kanya, "Halika. P\*\*\*\*\* j\*\* mo. Ang apo ko si Stone is barely one year. Ang ibig mong sabihin for 75 years magpunta ka diyan --- he will have to gamble for 75 years of his life."

That will only mean corruption. 75 years, must be crazy. Kaya ako nagalit.P\*\*\*\*\* j\*\*\*\*\* 'to. Siya ang inuna ko. Long before... So better go out quietly, I'm firing you. But I will not make a fuss about it. Sira ulo.Then, 50.That's too long. Ngayon, if you apply, it's denied because --- matagal ko ng sinabi 'yan eh. There will be a moratorium of the issuance of gambling franchise. Hinto muna.

Ako nagsusugal noon. As a matter of fact, when my father died, meron kaming dynamics, may away kami. Namatay 'yun di kami nagka-ano. Kasi nga yung mga manok ko pinapunggot 'yung ulo lahat doon sa likod ng bahay. Kaya nag-aral naman ako.Ang sabi, "Uy o `yung --- magpapabili ng manok 'yan." Totoo nag bree-breeding 'yan. Iyong katabi niya isa pa.So, take that reality sa utak niyo. No gambling.

Boracay, sabi nila, ah pagkatapos niyan ibigay ko sa mga friends ko mayaman, may gambling. Wala akong friends na mayaman na g\*\*\*. Marami akong friends na mayaman na hindi g\*\*\*\*. Hingan ng pera kay eleksyon na. Tonyboy. Kami ni Tonyboy, bata pa kami nito pareho kami ng subdivision. Bata pa kami. Magkakilala na kami. Hindi diyan by accident na sabi mo na...

Charles Gonzales. Si Charles nag --- nilagay ba niya? Baka hindi masabit siya nito. Sabagay, ano ba naman 'yang five thousand.Kung makinig 'yang Comelec na 'yan.Isa 'yan.

Other is itong communist insurgency. Kayo lahat mabuti 'yang magka... If you side with the NPA, sorry, hindi talaga ako suporta sa'yo. Kaibigan ko ang NPA. Kaibigan ko lahat. And as a matter of fact, I was the only, the only official of this land to cross the ideological barrier.

I was the only one who could go to the mountains, talk to them, demand for the release of hostages. Magkaibigan kami. Sabi ko, maybe we share the same horizon.

Ako kasi noon, na-fiscal. Ang kaso laban sa militar, pati pulis at rebelde, walang gustong humawak. Hindi ko sabihing natatakot sila. Basta lahat nag, "Sir, huwag ako." So sabi ni boss namin, si [Galicia?] "Rod, hawakan mo." Sabi ko, "Sige."

Ang ano ng NPA sa akin is wala. There's no special reason. Except that kungnaghahawak ako ng kaso tapos mahalata ako that the evidence is fabricated or planted. Meron niyan noon eh. Sasabihin ko talaga sa court, "Your honor, I move to dismiss the case." "Why?" "I cannot prove the criminal in --- the criminal charges and besides I think the evidence is fabricated." Iyon lang ang ano nila sa akin.

Kaya sila nagkaroon ng... Ang military naman pagka in the fulfillment of their duty, pagka performance 'yan nakasala 'yung bala nila naligaw nakadamay ng isang libo, sabi ko sa kanila, "Do not worry, I will answer for it personally."

Kaya ako 'yung dinemanda. Gusto ako dalhin doon sa Amerika, doon ako kulungin. Buang.Mga international court.Maniwala kayo.Bolador.

First round pa lang tumba na. Nung nilabas ko na 'yung depensa ko, tahimik na lahat. Hindi ko nilabas 'yun eh. Why? No mean --- no mean words from me. Tiningnan ko lang ilang istupido na abogado, ni isa talaga wala. Iyong isa immunity from suit, president, sitting president. Kaya hayaan...

Ang akin, eh kasi fiscal ako. Pag-upo ko sa mesa 'yang umaga mag-trial, ang unang tanungin ko sarili ko is, "Is this court, may jurisdiction ba?" Second question, "Am I the right prosecutor here?" Ganun.

Kung wala akong jurisdiction because I was not assigned here, I was only limited to cases assigned in this court, but not all, tiningnan ko. Hindi ito akin. Ang akin is military, police, pati rebelde.

Pero 'yung mga abusado 'yung magpatay ng mga ano --- like sa babae sunugin 'yung katawan, ah hinatid ko talaga sa impiyerno. About four military officers. Nangyari 'yan sa Calinan, alam ninyo 'yan. 'Yung sinunog 'yung katawan tinapon doon sa...

So 'yan ang ano ko. We can be together. Ngayon kung may mag-suporta sa atin, hindi rin ako tatanggi. Pero kung ako maghingi, hindi ko gawain 'yan. Pero alam nila politika, kung magsabi sila, "Rod, magsuporta kami." Pagkaganun, 'di ma --- ito politika man 'to, party matters, there's nothing wrong with that. O you talk to Inday or the rest and we will welcome any help.

Pero ang ibigay ko lang siguro is my endorsement. Vote for... Sino ba dito ano... *[Tatakbo ka, sir, no?Tatakbo ka ng --- Atty Lambino? Okay ka na diyang sa (unclear)? Ang alam kong gusto ko na gusto mo mag-senador ka pero --- o governor. Pero mag-usap na lang kayo ni Senator Angara o.]*

So ganun. Impossible man `yung politika na walang pera. Nagwi-wishful thinking ka diyan. Pero ako hindi talaga ako maghingì. I will not go out of my way calling it people with the money to say na --- but --- if they offer to help you guys, I won't have any objection. Wala akong... Ngayon kung gusto ninyo magtulong rin ako. *[applause]*

Dala-dala ko nga `yung sako, mga lima `yan paghati-hatian lang rin ninyo. So that is my thought because it would be very hard to form ngayon with the different cultural background or political dimension or it could be the paradigm of what you want the government to be.

Medyo ano tayo diyan, `di tayo magkakaintindihan. Like just the PDP, the agony of the DBP is it was too principled. Talaga.

So it was a party --- between only the father and the son. It was really a moribund but nabuhay noong nanalo ako because I was a --- may pagka-leftist ako eh, `yung ang leanings ko kaya doon ako.

I did not join any... Although kung ako ang pipiliin, my father was a Nacionalista. Ah, when he died, he was a Nacionalista. So he would have --- sana ang gusto ko, ang ano ko talaga. But because of the... How would you call it? Iyong ano ng --- a mixed up of so many things, finances, whether you can agree to work or not.

But that's the things that you have to consider when you arrive at a certain decision. It becomes the threshold of saan ka papunta. I do not like to change parties. So I will remain where I am. But you --- ang pinaka-advice ko is you connect with your traditional mother unit.

Whether or not they were helped, wala na `yan. But they are these guys that who can connect with the moneyed people. But when the votes are counted, if it's crucial to Republic, it is always --- mabuti't na lang andito si President Arroyo.

I mean he can hold the line dito sa Congress. Only that --- ang akin naman only those measures that would be of good to the Filipino nation. I cannot support for the life of me measures that would cost detriment to the people. `Di talaga ako pwede. So pasensya na lang.

And I said I had many options. Retire quietly or retire with a big bang or if I do not get there, then at least... Basta ako, para sa Pilipino at maasahan ninyo that I will serve.

And ang number one ko rin corruption pa rin. So it's corruption, I cannot help you. I cannot call anybody. I do not do it. I do not even --- I have not even called Bato o si Ma'am Pia, si Imee, Roque, si Ma'am Cynthia. Maski nga si Inday hindi ko nga alam kung --- `di ko alam kung may cellphone `yan o wala. Wala siguro. Senator Angara din.

You can ask anybody. I have never called cell --- girls only. *[laughter]* Kasi `pag dial ko, "I'm sorry, this call is barred, only for girls." *[laughter]* Eh `di wala.

So `yan ang stand ko. I can support you morally, politically. Kung making pa ang tao sa akin. If I can contribute anything sa --- `yung pagkatao ko. Maybe ang madala ko `yung easily, mga Bisaya, Mindanao, pero doon sa --- I don't know.

But Inday has prepared a... Nag-greet na ba kayo? Hindi ay, kilala --- kilala naman ninyo sila. So kaawa naman itong babae. Kayo nag-prepare nito? Speech ko, kita mo naghihintay o kung... Baka nag-madaling araw ito sila nag --- basahin na lang natin maski `yung last paragraph lang.

This is the last paragraph of... Kasi dalawa. Katagal ninyo naghintay sa akin, ibibigay ko `to sa inyo? "G\*\*\* pala ito si Duterte." Mabuti nga.

Let me reiterate that this administration remains committed to preserve and defend our most cherished democratic values, one of which is the vibrant party dynamics in the Philipp --- political environment. Indeed, it is only through an open democratic society that we can truly uphold ideals that we hold dear.

I assure you that this is only the beginning. I look forward to the many of the things that we can accomplish together in the years to come.

May this new chapter in our party's history or group or whatever inspire us to further continue upholding excellence, accountability and solidarity as we bring genuine transformation to all the Filipino.

Daghang salamat ug mabuhay ang Hugpong! *[applause]*

Ito ano, pssst! Ibalik mo. In this election, I commit to the Filipino people that this will be a clean election. Ako `yung... *[cheers and applause]*

Sabihin ko sa Comelec i-deputize personally ako. There will be voting and the votes will be counted correctly. *[applause]* And in the next few months, I



will impose the Alunan doctrine. You cannot bring long firearms during election time. *[applause]*

Sana itong mga NPA, do not mess up kasi pati kayo nakikinabang. Huwag kayong makialam at maghingì ng taxation kasi mas malalo tayong lalayo nang lalayo nang lalayo sa solusyon natin. Huwag kayong makialam kasi election 'to. Do not terrorize and I will tell the Armed Forces and the police not to interfere if you are not deputized by the Comelec. *[applause]*

Maski saan, ma-Jolo o ma-Abra, 'pag may narinig ako na terrorism, ako mismo ang pupunta and I will enforce the law. And if I have to do it, bahala kayo. Ginusto ninyo 'yan. Eh --- basta sabi ko walang terorismo't walang --- walang makadala ng baril except maybe the police.

The Army is prohibited from joining political [sortition?]. The military wala -- - pulis lang. And the checkpoints will be --- checkpoints will be established at kung may baril to arrest the candidate together with --- confiscate the firearms.

So you're better off isa, dalawa. Tatal, kung ambushin (ambush) ka talaga, patay ka na sa totoo lang. From election victory, necrological services kaagad na tayo. Kaya totoo. How can you escape assassination kung magtindig ka diyan? Eh 'yung granada i-ganun lang 'yan.

It's actually it's useless. Ako na ang bahala sa mga bad boys. 'Yung mga goods, ah 'pag ayaw ninyong maniwala, sinasabi ko na sa inyo, I have committed to the people. Itong election na ito, 'pag kayo 'yang naghihintay lang ng pera, nakakatrabaho during election time, pumatay man, nakatago, uunahin ko na kayo. Sigurado 'yan. Ako ang kaharap ninyo. Pero kung ang bodyguard ninyo maganda, palusutin ko kayo pero iwan mo 'yung bodyguard kay... *[applause]*
