**SUBJECT : BIDS AND AWARDS COMMITTEE (BAC) – I RESOLUTION
DECLARING FAILURE OF BIDDING FOR THE
PROCUREMENT OF OFFICE SUPPLIES (CONTRACT NO.
2019-PCOO-I-004)**

DATE : 09 August 2019

WHEREAS, the mode of procurement of office supplies as provided in the 2019 Annual Procurement Plan (APP) of the Presidential Communications Operations Office (PCOO) is through competitive bidding;

WHEREAS, the aforementioned procurement project was commenced upon the posting of the invitation to bid on 28 June 2019 on the Philippine Government Electronic Procurement System (PhilGEPS) website, the PCOO website, and the bulletin board located at a conspicuous place within the New Executive Building, Malacañang Compound, Manila;

WHEREAS, the deadline of submission of bids was scheduled on 09 August 2019 at nine o'clock in the morning (9:00 AM) at the PCOO BAC Secretariat Office;¹

WHEREAS, upon the lapse thereof, no bidding documents were purchased, hence, no bids were received;

NOW, THEREFORE, in view of the foregoing, the BAC-I, constituting a quorum, resolves, as it is hereby resolved, to:


1. declare a failure of bidding for the aforementioned procurement project; and
2. direct the end-user unit, the Property Division, in coordination with the General Services Division, to:
 - a. conduct the mandatory review of the terms, conditions and technical specifications pursuant to Section 35.2² of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184; and
 - b. submit its recommendation to the BAC-I on or before 13 August 2019 at twelve o'clock noon (12:00 PM).


