1. The Presidential Communications Operations Office (PCOO), through the General Appropriations Act of 2019* (YEAR) intends to apply the sum of PHP 5,632,200 . 00 (ABC), being the Approved Budget for the Contract (ABC), to payments under the contract for Procurement of IT Equipment and Software Applications (Contract No. 2019-PCOO-I-008a) for

Bids received in excess of the ABC/s shall be automatically rejected at bid opening.

2. The PCOO now invites bids for **the Procurement of IT Equipment and Software Applications as described in Sec. VII. Technical Specifications (Lot 2 only)**
(BRIEF DESCRIPTION OF THE TYPES OF GOODS, INCLUDING QUANTITIES, LOCATION OF PROJECT, AND OTHER NECESSARY INFORMATION).
Delivery of the Goods is required within 45 days from the issuance of Notice of Award (REQUIRED DELIVERY DATE / EXPECTED CONTRACT DURATION). Bidders should have completed, within THREE (3) YEARS (RELEVANT PERIOD) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the PCOO, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
