**SUBJECT : RESOLUTION ADDRESSING THE FREQUENTLY
ASKED QUESTIONS IN RELATION TO THE 6TH
EDITION OF THE PHILIPPINE BIDDING DOCUMENTS**

DATE : 11 December 2020

WHEREAS, on 28 July 2020, GPPB Resolution no. 2020-0015 was issued approving the adoption of the sixth (6th) edition of the Philippine Bidding Documents of Goods and Infrastructure Projects and related amendments in the 2016 Revised Implementing Rules and Regulations of R.A 9164;

WHEREAS, on 14 August 2020, the 6th edition of the Philippine Bidding Documents took effect and was adopted by the GPPB and other Procuring Entities upon the lapse of fifteen (15) days following the publication in the Official Gazette;

WHEREAS, in relation to the publication of the new Philippine Bidding Documents (6th Edition), several inquiries as to the template of the new bidding documents were raised by prospective bidders;

NOW THEREFORE, in line with the inquiries on the Bid Form Template and Statement of Largest Completed Contract, this Committee resolved to advise all prospective suppliers for all prospective projects that will undergo public bidding as follows:

- I. For Bid Form (Appendix I) in the Bidding Documents, a bidder who intends to participate in multiple lots are required to indicate the lot number and bid amount for each lot in words and figures;
- II. In relation to the Bid Form, if there is no Foreign-Assisted project with Development Partner (Commission or gratuities), the bidder may omit the said paragraph **or** state “none” in the blanks if not applicable to their source of bid;
- III. For the Statement of All Ongoing Government and Private Contracts (SAOGPC), the contracts stated therein shall be a part of their Legal and Technical Documents in order to substantiate what was stated in their SAOGPC;
